



# INFORMATION FOR KFU GRADUATES:

## RECOGNITION OF RUSSIAN DIPLOMAS



After getting your KFU diploma, at the Embassy of your country find out the information on the documents necessary for the recognition of a Russian diploma in your home country

Usually the recognition procedures include 2 steps:



**Legalization -**  
is a procedure of a document's verification carried out in Russia



Undergo this procedure before leaving for your home country

### STEP 01

**Legalization is not required for the nationals of the following countries:**

Azerbaijan, Albania, Algeria, Argentina, Armenia, Belarus, Bulgaria, Bosnia and Herzegovina, Hungary, Vietnam, Greece, Georgia, Egypt, India, Iraq, Iran, Spain, Italy, Yemen, Kazakhstan, Cyprus, China, North Korea, Cuba, Kyrgyzstan, Latvia, Lithuania, Macedonia, Moldova, Mongolia, Poland, Romania, Serbia, Slovakia, Slovenia, Tajikistan, Tunisia, Turkmenistan, Uzbekistan, Ukraine, Finland, Croatia, Montenegro, Czech Republic, Estonia.

**Academic recognition of a diploma-**  
is a procedure certifying the validity of the issued diploma

Undergo this procedure upon arrival to your home country

### STEP 02



If you intend to continue your studies not only at your home country, but also abroad, it is recommendable to get the Apostille of the original document. This type of legalization shall be valid in over 100 states - participants of the Hague Apostille Convention
